# Message from Leadership

Lone Star CASA has trained and supported volunteers for over 30 years as they build relationships with children who have experienced abuse and neglect and advocate on behalf of their best interest in court and beyond. While advocates gleam insight from and encourage healthy relationships amongst important players in children's lives, judges depend on the information they gather and recommendations they provide to help children find permanency quickly.

In 2023, we saw a 135% rise in new children in need of our services and to keep up with that growth we are proud to report that we swore in 19 new advocates. The Texas Tribune recently reported that Kaufman County is the fastest growing county in the nation with Rockwall County close behind. Because of this, it's been crucial that we grow our staff and increase volunteer recruitment and retention efforts to meet the need.

At the beginning of our fiscal year, we officially expanded our Collaborative Family Engagement Program into Kaufman County. Laying the ground work for this expansion in the previous year, we are proud to report that we have been working with 39 newly eligible families to help develop life-long support systems that will help foster a healthier environment to grow up in. Lone star CASA also received its first Order To Participate (OTP) case at the beginning of FY 2023. Since then, we have served on 11 of these cases. During the 2023 legislative session, a bill introduced to allow state funding for OTP services died, creating a void in consistent funding for these efforts. In response, we worked to sure up funding from private foundations so that we can prevent child abuse and neglect while keeping kids in homes. OTP allows us to helps families identify and remove barriers that might prevent them from completing services crucial in eliminating threats to child safety and security.

In addition, the state began it's transition into privatizing the Child Welfare system this past year. Our region is the largest to transition to this model yet, and with our DFPS region having more children in care than any other, Lone Star CASA is committed to stepping up to support a smooth transition. Our advocates bring a wealth of knowledge regarding case histories, and this makes the ongoing success of our organization more vital than ever as the new region provider leans on us to gleam support from our knowledge, experience, and resources.

During this time of exponential growth and sweeping changes to care, Lone Star CASA will remain a dependable and trustworthy presence in vulnerable children's lives. With your support, Lone Star CASA will continue implementing innovative programs that seek to repair harm, heal trauma, strengthen familial bonds, and prevent child abuse and neglect.

## **Order To Participate**

Lone Star CASA is the first in Texas to implement this preventative program.

We support children while facilitating parent involvement in services that directly address risk factors that impact child safety.

We have served on 10 OTP cases in FY 2023 and we have helped 5 other CASA's in Texas begin OTP.

# Collaborative Family Engagement

We help grow networks of support by identifying family and lifetime connections for each child. We accomplish this by fostering these connections and building healthy relationships that improve the well-being of children and families. In FY 2023, we completed 1,446 CFE activities with the families of 68 children.

87% of families were reunified or placed with relatives.




Volunteer scored 4.8 out of 5 on being adequately trained to fulfill their duties as Advocates.




